PURCHASER EXPRESSLY REPRESENTS THAT HE OR SHE HAS NO KNOWLEDGE WHATSOEVER OF ANY EXISTING DAMAGE THAT IS NOT EXPRESSLY NOTED ON THE ATTACHED INSPECTION GRAPH. In the event of additions or alterations to the identified property, purchaser must give prior notice and arrange with TORCO for additional service at the expense of purchaser. Upon transfer of ownership of the identified property, this plan may be continued upon the terms and conditions herein. ALL ADDITIONAL PROVISIONS ON THE REVERSE SIDE HEREOF, AND THE INSPECTION GRAPH ARE INCORPORATED HEREIN, INCLUDING THE ARBITRATION PROVISION HEREIN.
